#### **Definition**

“Cricket Activities” include league matches, tournaments, practices, training, travel to and from venues, use of facilities and equipment, officiating, volunteering, and all activities connected to cricket organized or authorized by the Releasees.

#### **Protective Equipment**

I acknowledge that cricket involves hard balls, bats, and physical activity and that protective equipment such as helmets, pads, gloves, abdominal guards, and proper footwear is strongly recommended.

#### **Assumption of Risks**

I understand that participation in Cricket Activities involves risks including being struck by a ball or bat, collisions with other participants, slips, trips and falls, uneven or wet playing surfaces, weather conditions, overexertion, dehydration, equipment failure, travel risks, and negligence of other participants or the Releasees.

I freely accept and assume all such risks, including the possibility of serious injury, permanent disability, death, or property damage.

#### **Release of Liability and Indemnity**

In consideration of participation in Cricket Activities, I waive and release any and all claims against the Releasees for any injury, loss, or damage arising from participation, including claims due to negligence, breach of contract, or statutory duty of care, including under the Occupiers Liability Act.

I agree to indemnify and hold harmless the Releasees from any claims brought by third parties arising from my participation.

This agreement is binding upon my heirs and representatives and is governed by the laws of the Province of British Columbia. Any legal action shall be brought exclusively in British Columbia courts.
